It has been another exciting year for Bike Winnipeg! We have all been very busy this year promoting cycling as an alternative to driving in Winnipeg. We would like to thank all of our board members for their hard work at our monthly meetings and for the work they do between meetings on their committees and in the community. We would also like to thank the many volunteers that sit on committees, that volunteer for our community outreach and the folks that help Shawn park bikes all summer long and make our Bike Valet possible.

We are really excited this year with the work done by our education committee. The BEST program was a huge success and it sounds like there is a lot of interest to expand it into other schools in Seven oaks and other metro school divisions.

Our policy committee has been hard at work this year crafting evidence based policies that will help guide Bike Winnipeg representatives when speaking with the public, the media and with elected officials. The work that we have been doing will go a long way to help our organization provide government, the public and media with informed and evidence based positions on a number of issues that affect people that ride bikes in Winnipeg.

Our advocacy committee has continued to make inroads with MPI over the year with the work they have conducted with at the PUB rate hearings. In 2016, MPI has reviewed it's advertising messaging for 2017, and they have promised to change from a 'share the road' campaign, which was ambiguous as to which road user should be



sharing, to a message in line with what Bike Winnipeg has been recommending. We would like to thank Jason Carter and Charles Feaver for all of the time they have put into guiding our council Christian Monnin at the PUB hearings.

Our membership and fundraising and membership awareness committee has also been hard at work this year securing funds for the work Bike Winnipeg does through fundraising, memberships and events.

Shawn Defoort has done an excellent job with our Bike Valet this year. He parked 2798 bikes over the 2016-2017 season and was involved in a number of different community events. He certainly got more people biking to events that he was working at!

As Co-chairs we participate in committees, organize monthly meetings and look after the governance and organizational structure of Bike Winnipeg. We would like to thank Bill Newman who has done a great job of monitoring and reporting on our finances.

We want to acknowledge our Executive Director Mark Cohoe. He is, in our opinion, a superman of cycling advocacy. He has a wealth of knowledge on everything from infrastructure to research on the efficacy of laws that protect cyclists. OUR EXECUTIVE DIRECTOR

It is difficult to catch a glimpse of our Executive Director, Mark Cohoe. You can usually catch him riding the streets of Winnipeg on his bicycle, attending community events about cycling, speaking with the media and politicians, and helping out whenever he can. EDUCATION COMMITTEE

During 2016 the Education Committee focused on two main initiatives:

- 1. Skills Training (BEST) Pilot Program
- 2. Bicycle Education

In December, 2015 Bike Winnipeg organized a meeting to discuss experiences and ideas for promoting bicycle education for children. The meeting was attended by 17 people from different organizations involved with bicycling education. At this meeting, Bromley presented a Bike Winnipeg proposal for a pilot project for a bicycle education program to be delivered in the school system as part of the physical education curriculum. The concept was for a pilot program to be developed and delivered as a physical education unit to students in grades four through eight. A steering committee was formed to move this proposal forward, including representatives of the Active and Safe Routes to School (ASRTS) program, the WRENCH, Bike Winnipeg, CAN-BIKE, and Manitoba Public Insurance. The committee is chaired by Jamie Hilland of ASRTS.

Following the December meeting MPI offered to provide financial support for the program and the Seven Oaks School Division quickly signed on to the concept. As a result, plans were put in place to deliver the program starting in the fall of 2016. In June Bob Lawrie, who has a background in sport education, was hired as program coordinator and tasked to develop a curriculum over the summer and be the program instructor in the fall. Seven Oaks School Division bought a fleet of bicycles and helmets and provided support for participating physical education teachers to receive bicycle education training in early September. Individual schools and physical education teachers worked with the program coordinator to scheducle classes and assign teachers. MPI provided \$25,000 in financial support, bicycle training for teachers and project management and evaluation staff time.

In September and October 2016 the program was delivered to 28 classes in grades four through eight with a total enrolment of approximately 700 students. Each class received six periods of instruction and were taught basic cycling skills, rules of the road and how to cycle on city streets. Instruction took place outdoors and mainly involved group rides with the program coordinator and two other teachers. Students who did not know how to ride a bike when the program began were taught separately, largely through the volunteer assistance of Mark Cohoe. The program was publicly announced in October. An evaluation was planned and carried through surveys, interviews and other data collection from the project schools and control schools. Initial indications are that the program has been well delivered and well received by parents, students and schools. Funding and staffing resources have been an issue for the program. MPI has agreed to again provide \$25,000 in funding for 2017 plus continued staff support, and the City of Winnipeg has made a funding commitment to the project of \$15,000 per year for the next three years. Current plans call for the program to be delivered in a second set of schools in the spring. The program is to be continued for at least two more years, delivered to students in grades four through eight each year.

If successful the goal is to see the program adopted by Manitoba Education as an approved and supported curriculum option, and delivered in school divisions throughout the province. Interest in the program has been expressed by other Winnipeg school divisions, and we have had inquiries about the program from other cities in Canada and the U.S. At this point our capacity is limited and we are focusing on delivering and evaluating the pilot project, making adjustments to the program as we proceed.

Employer Based Cycling Education (Bike It)

Two years ago Bike Winnipeg developed and delivered a pilot commuter cycling education program in cooperation with Manitoba Hydro. In 2016 MPI and Bike Winnipeg collaborated on the development of a similar program called "Bike It." The program was to be delivered to MPI employees as well as at two other employers where there had been interest expressed. The program was developed but actual program delivery was very limited, partly because there were delays getting the program defined such that it was not available until summer, and there was little interest in the program by that time.

Adult commuter cycling education is a program area that we will need to reconsider in the future. Ultimately there seems to be little motivation on the part of most potential commuters. Nevertheless an MPI supported commuter cycling course now exists which might be successful with better and more timely promotion in 2017.

POLICY COMMITTEE

After a brief hiatus in early 2016, a reconstituted Policy Committee got to work. After determining that our focus should be on researching and formalizing position statements to support the Board's advocacy work and to guide interactions with the media and public, we developed a format for these statements and then focused on three priority areas. Position statements on general Traffic Control Measures, Vision Zero, and Neighbourhood Greenways were developed and approved by the Board in 2016. Once approved, these were each posted on the Bike Winnipeg website so as to also be available to the members and the public.

In late 2016 we then began work on position statements with regards to Diamond Lanes, and the always contentious Bike Helmet Legislation.

Moving forward into 2017 will be work on Snow Clearance of AT Routes, One Metre Safe Passing Distance, and a city-wide Wayfinding Strategy.

ADVOCACY COMMITTEE

In addition to working with Executive Director Mark Cohoe to promote bike friendly solutions to city infrastructure projects, members of the Advocacy committee worked on improving safety for cyclists on roads in Manitoba.

We were again recognized as full intervenors at the Public Utilities Board review of the MPIC application for programs and rates for 2017/18. We engaged a lawyer to represent Bike Winnipeg. Our objectives at this hearing were to argue:

- 1. MPI road safety programs should focus on reducing accidents that cause injuries and deaths, and
- 2. MPI should develop road safety programs that effectively tell drivers how to steer around cyclists.

MPI presented the framework for its 2017/18 road safety program. Once again, the cycling safety program is inadequate. We have been advised outside the hearing that the cycling safety advertising message for 2017 will be significantly changed, and will be in line with one of the messages that Bike Winnipeg advocates. We have indicated that we will support this advertising campaign.

In the hearing, MPI indicated that they are beginning to look at measuring the social costs of collisions, and working with the Province on a Vision Zero approach to road safety. This is encouraging news, but it has not changed MPI's basic methodology of allocating priorities or resources to road safety.

In their decision, the Board found that further work is required in order for MPI to demonstrate that its road safety programming has reached maturity. The Board looks to the Corporation to take a more aggressive approach and to further its leadership role regarding road safety planning and strategy in Manitoba. It ordered MPI to file a five-year strategic plan with respect to road safety programming, addressing road safety issues including distracted driving, drug-impaired driving, wildlife collision prevention, mature drivers, and vulnerable road users. This is a multi-year process.

Also, advocacy committee members have been participating in the MPI road safety stakeholders committee, arguing for:

- The need for a Vision zero road safety initiative
- **Better data collection and sharing**
- Teaching drivers correct behaviours.

MISSION:

To encourage the use of bicycles by providing a free and safe method of securing your bicycle at events located around the Winnipeg region.

- Brovides a temporary bicycle parking facility for your event
- Helps reduce traffic and parking congestion.
- Encourages Active Transportation use in Winnipeg.
- There is no charge to cyclists for using this service.
- Bicycles are stored in a supervised compound.
- Will accept any A.T. equipment such as: skateboards, strollers, chariot trailers.

2016 EVENTS SUMMARY

- Active at 17 events over 23 days throughout the season
- 2798 bikes parked in total
- Average of 127 bikes parked per day
- Twelve (12) different clients/event organizers
- New events this season included:
 - © Clean Air Day (The Forks, Green Action Centre)
 - © CMHA "Ride Don't Hide" fundraiser (Fort Whyte Alive)
 - MEC Trail Race series (Assiniboine Park)

Bicycle Valet Operations

Staffing:

Doodle, an online booking calendar, is used as a registration system for volunteers

- 41 active volunteers in 2016, 14 of which were new recruits
- Volunteers contributed a total of 652 hours in the 2016 season, an average of about 16 hours per volunteer
- BVW volunteer tasks include:
 - Transporting equipment to and from events
 - Setting-up and tearing-down the fencing and bike racks
 - Ticketing bicycles
 - Parking and retrieving bicycles

Transportation:

- BVW owns bicycle trailers that are used when possible to transport equipment to the event.
- For larger events, BVW relies on cargo van rentals to transport gear to and from events

Priorities in 2017


- Volunteer recruitment at schools & universities

BVW Expenses Breakdown

- Vehicle rental & fuel
- Volunteer stipends
- Insurance
- ■Assistant wages
- Printing
- Storage
- Supplies
- Volunteer appreciation

Finances:

- Event organizers pay for service according to duration of the event and number of bikes
- Donations from cyclists are accepted on-site and account for about 9% of total revenue
- 15% of revenue goes directly to Bike Winnipeg, the rest is retained by the coordinator and used to pay operational expenses
- The event organizer may receive a 10% discount for providing "in-kind" services, such as food for our volunteers or a vehicle to transport equipment


